

CONSENT, WAIVER AND INDEMNITY AGREEMENT

I am the parent or person having legal custody or guardianship of _____ who are/is a minor(s) (the "Minor(s)"). I freely give my permission for the Minor(s) to participate fully in The Hiram House activities program (the "Program"). I am completely satisfied that the Minor(s) is physically able and mentally prepared to participate in all of the Program activities described in the registration flyers and in the information below, including horseback riding.

I understand that activities involving horses involve inherent risks that cannot be eliminated. I understand that horses can behave in ways that might cause damage to personal property, or injury, even serious injury or death, to people on or around the horse. I also understand that sometimes a person acting negligently around a horse might make the horse act in a way that causes harm to people or property nearby.

In return for Minor(s) being allowed to enter The Hiram House, to use its facilities and equipment, and to participate in the Program, on my own behalf and on behalf of Minor(s), I make the following promises:

1. I have read and understood this document;
2. The health history is correct and complete to the best of my knowledge.
3. I accept the facilities as being safe, properly maintained and reasonably suited for the Program purposes;
4. I have had a fair opportunity to interview the supervisory personnel for the Program's activities, and am satisfied that they are reasonably well qualified for their responsibilities;
5. I will not sue or hold The Hiram House, or its trustees, officers, employees and agents ("Released Parties"), responsible in any way for any property damage, personal injury, or any other type of injury, to me or to Minor(s), that arises from or relates to Minor(s) participation in the Program; and
6. I will defend and protect Released Parties against any claims brought against them that arise out of or relate to Minor(s) participation in the Program. I agree to do this whether or not the claims were contributed to by Released Parties. This agreement includes agreeing to pay for attorneys who will represent Released Parties if they are sued.

I voluntarily sign this document. I intend it to protect the Released Parties to the fullest extent Ohio law permits. If any part of this document is unenforceable, I agree the remainder shall continue to be enforceable.
